A copy of the income tax returns for the parent(s) responsible for your college education is required. The forms must state income earned for the year. The forms are required in order for you to qualify for the need portion of the scholarship. Feel free to place your income tax forms in a sealed envelope to ensure the person vetting the scholarships is the only one to see that information. This information will not be shared with anyone in the club. All information given is shredded at the end of the selection process. Your application is deemed incomplete without tax returns attached and will not be reviewed.
